#### **2026 Buell 1190 HAMMERHEAD/SX/SUPERTOURING/SUPER CRUISER MOTORCYCLE**

#### **12 Months/Unlimited Miles**

Buell warrants for any new 2026 Buell motorcycle that an authorized Buell dealer or service center will repair or replace without charge any parts found under normal use to be defective in factory materials or workmanship. Such repair and replacement will be Buell's sole obligation and the customer's sole remedy under this warranty. THERE IS NO OTHER EXPRESS WARRANTY (OTHER THAN THE SEPARATE EMISSIONS AND NOISE WARRANTIES) ON THE MOTORCYCLE. ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE IS LIMITED TO THE DURATION OF THIS WARRANTY. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

TO THE FULLEST EXTENT ALLOWED BY LAW, BUELL AND ITS DEALERS OR SERVICE CENTERS SHALL NOT BE LIABLE FOR LOSS OF USE, INCONVENIENCE, LOST TIME, COMMERCIAL LOSS, OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may have other rights which vary from state to state.

The following terms and conditions apply to this warranty:

#### **DURATION**

1. The duration of this limited warranty is twelve months, starting from the earlier of (a) the date of the initial retail purchase and delivery from an authorized Buell dealer or service center, or (b) the second anniversary of the last day of the model year of the motorcycle. Your dealer or service center will submit an electronic Sales and Warranty Registration form to initiate your warranty.
2. Any unexpired portion of this limited warranty will be transferred to subsequent owners, upon the resale of the motorcycle during the warranty period.

#### **OWNER'S OBLIGATIONS**

To obtain warranty service, return the motorcycle at your expense within the warranty period to an authorized dealer or service center. Our dealer or service center should be able to provide warranty service during normal business hours and as soon as possible, depending on the workload of the dealers or service centers service department and the availability of necessary parts.

## EXCLUSIONS

### **This warranty will not apply to any motorcycle as follows:**

1. Which has not been operated or maintained as specified in the Owner's Manual.
2. Which has been abused, misused, improperly stored, used "off the highway" or used for racing or competition of any kind.
3. Which is not manufactured to comply with the laws of the market in which it is registered.
4. Installing off-road or competition parts to enhance performance may void all or part of your new motorcycle warranty. See a Buell dealer or service center for details.
5. Acts of God, war, riot, insurrection, natural disasters, including but not limited to, nuclear contamination, lightning, dust storms, hail storms, ice storms, earthquakes, floods, or for other circumstances out of Buell's control.

### **OTHER LIMITATIONS**

This warranty does not cover:

1. Parts and labor for normal maintenance as recommended in the Owner's Manual, or the replacement of parts due to normal wear and tear including such items as the following: tires, lubrication, oil and filter change, fuel system cleaning, battery maintenance, engine tune up, spark plugs, brake, clutch and chain/ adjustment (including chain replacement).
2. Cosmetic concerns that arise as a result of owner abuse, lack of proper maintenance or environmental conditions (except concerns that result from defects in material or workmanship, which are covered by this warranty for the duration of the warranty period).
3. Any cosmetic condition existing at the time of retail delivery that has not been documented by the selling dealer or service center prior to retail delivery.
4. Defects or damage due to the motorcycle caused by alterations outside of Buell factory specifications.

### **IMPORTANT: READ CAREFULLY**

1. Our dealers or service center are independently owned and operated and may sell other products. Because of this, **BUELL IS NOT RESPONSIBLE FOR THE SAFETY, QUALITY, OR SUITABILITY OF ANY NON-BUELL PART, ACCESSORY OR DESIGN MODIFICATION INCLUDING LABOR WHICH MAY BE SOLD AND/OR INSTALLED BY OUR DEALERS or SERVICE CENTERS.**
2. This warranty is a contract between you and the manufacturer. It is separate and apart from any warranty you may receive or purchase from the dealer or service center. The dealer or service center is not authorized to alter, modify, or in any way change the terms and conditions of this warranty.
3. Any warranty work or parts replacement authorized by the manufacturer will not preclude the manufacturer from later relying on any exclusion where applicable.

### **2026 BUELL NOISE CONTROL SYSTEM LIMITED WARRANTY**

The following warranty applies to the noise control system, is in addition to the **MOTORCYCLE LIMITED WARRANTY** and applies only to motorcycles sold in the U.S.

Buell warrants that this vehicle is designed and built so as to conform at the time of sale with applicable regulations of the U.S. Environmental Protection Agency (as tested following f-76 Drive-By test procedure) and that it is free from defects in materials and workmanship which would cause this motorcycle not to meet such U.S. Environmental Protection Agency Standards within 1 year from initial retail purchase and delivery from an authorized Buell dealer or service center, or one year from the second anniversary of the last day of the model year of the motorcycle, or 3,730 miles (6,000 km) whichever expires first. Any unexpired portion of this limited warranty will be transferred to subsequent owners, upon the resale of the motorcycle during the warranty

period. If the motorcycle was used as a demonstrator, then the Warranty period may have started and/or expired prior to the initial retail sale. See a Buell dealer or service center for details.

THERE IS NO OTHER EXPRESS WARRANTY (OTHER THAN THE SEPARATE MOTORCYCLE AND EMISSIONS WARRANTIES) ON THE MOTORCYCLE. ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE IS LIMITED TO THE DURATION OF THIS WARRANTY.

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

The warranty period shall begin on the date the motorcycle is delivered to the first retail purchaser or, if the motorcycle is placed in service as a demonstrator or company vehicle prior to sale at retail, on the date it is first placed in service.

2. Replacing, removing, or modifying any portion of the NOISE CONTROL SYSTEM (consisting of the exhaust system and air intake/cleaner assembly) with parts not certified to be legal for street use.
3. Any motorcycle on which the odometer mileage has been changed so that the mileage cannot be determined.
4. TO THE FULLEST EXTENT ALLOWED BY LAW, BUELL AND ITS DEALERS OR SERVICE CENTER SHALL NOT BE LIABLE FOR LOSS OF USE, INCONVENIENCE, LOST TIME, COMMERCIAL LOSS OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES.

### **EMISSION CONTROL SYSTEM SUPPLEMENTAL WARRANTY**

#### **YOUR WARRANTY RIGHTS AND OBLIGATIONS**

The U.S. Environmental Protection Agency (EPA) and Buell Motorcycle Co. are pleased to explain the emission control system warranty on your 2026 and later motorcycle. In California, new motor vehicles must be designed, built and equipped to meet the State's stringent anti-smog standards. In all other states, new motor vehicles must be designed, built, and equipped to meet U.S. EPA Federal anti-smog standards. Buell Motorcycle Company must warrant the emission control system on your motorcycle for the periods of time listed below provided there has been no abuse, neglect or improper maintenance of your motorcycle.

Your emission control system may include parts such as the fuel-injection system, the ignition system, catalytic converter, oxygen sensors, fuel pump, and engine computer. Also included may be hoses, belts, connectors and other emission-related assemblies.

Where a warrantable condition exists, Buell Motorcycle Company will repair your motorcycle at no cost to you, including diagnosis, parts and labor.

### **MANUFACTURER'S EMISSION CONTROL SYSTEM SUPPLEMENTAL WARRANTY COVERAGE**

Class III motorcycles (280 cc and above): for a period of use of five (5) years or 30,000 kilometers (18,641 miles), whichever first occurs.

If an emission-related part on your motorcycle is defective, the part will be repaired or replaced by Buell Motorcycles.

This is your emission control system DEFECTS WARRANTY.

#### **OWNER'S EMISSION CONTROL SYSTEM SUPPLEMENTAL WARRANTY RESPONSIBILITIES**

- As the motorcycle owner, you are responsible for the performance of the required maintenance listed in your owner's manual. ### **BUELL MOTORCYCLE CO - LIMITED WARRANTY ON EMISSION CONTROL SYSTEM**

BUELL MOTORCYCLE warrants that each new 2026 and later BUELL brand motorcycle, which includes as standard equipment, a headlight, taillight and stoplight, and is street legal:

A. is designed, built and equipped so as to conform at the time of initial retail purchase with all applicable regulations of the

United States Environmental Protection Agency; and

B. is free from defects in material and workmanship which cause such motorcycle to fail to conform with applicable regulations of

the United States Environmental Protection Agency for a period of use of 30,000 kilometers (18,641 miles), if the motorcycle's engine displacement is equal to or greater than 280 cubic centimeters; or 5 (five) years from the date of initial retail delivery, whichever first occurs.

#### **I. COVERAGE**

Warranty defects shall be remedied during customary business hours at any authorized BUELL motorcycle dealer or authorized service center located within the United States of America in compliance with the Clean Air Act and applicable regulations of the United States Environmental Protection Agency. Any part or parts replaced under this warranty shall become the property of BUELL MOTORCYCLE CO.

#### **II. LIMITATIONS**

This Emission Control System warranty shall not cover any of the following:

A. Repair or replacement required as a result of

(1) accident,

(2) misuse,

(3) repairs improperly performed or replacements improperly installed,

(4) use of replacement parts or accessories not conforming to BUELL MOTORCYCLE CO. specifications which adversely affect performance and/or

(5) use in competitive racing or related events.

B. Inspections, replacement of parts and other services and adjustments required for required maintenance.

C. Any motorcycle on which the odometer mileage has been changed so that actual mileage cannot be readily determined.

### III. LIMITED LIABILITY

A. The liability of BUELL MOTORCYCLES under this Emission Control System Warranty is limited solely to the remedying of defects in material or workmanship by an authorized BUELL MOTORCYCLES motorcycle dealer or service center at its place of business during customary business hours. This warranty does not cover inconvenience or loss of use of the motorcycle or transportation of the motorcycle to or from the BUELL MOTORCYCLES dealer or service center. BUELL MOTORCYCLES shall not be liable for any other expenses, loss or damage, whether direct, incidental, consequential or exemplary arising in connection with the sale or use of or inability to use the motorcycle for any purpose. Some states do not allow the exclusion or limitation of any incidental or consequential damages, so the above limitations may not apply to you.

#### EBR MOTORCYCLES, LLC, DBA BUELL MOTORCYCLES - LIMITED WARRANTY ON EMISSION CONTROL SYSTEM

BUELL warrants that each new 2026 and later BUELL brand motorcycle, which includes as standard equipment, a headlight, taillight and stoplight, and is street legal:

A. is designed, built and equipped so as to conform at the time of initial retail purchase with all applicable regulations of the California Air Resources Board; and

B. is free from defects in material and workmanship which cause such motorcycle to fail to conform with applicable regulations of the California Air Resources Board for a period of use of 30,000 kilometers (18,641 miles), if the motorcycle's engine displacement is equal to or greater than 280 cubic centimeters; or 5 (five) years from the date of initial retail delivery, whichever first occurs.

#### I. COVERAGE

Warranty defects shall be remedied during customary business hours at any authorized BUELL dealer or service center located within the United States of America in compliance with the Clean Air Act and applicable regulations of the California Air Resources Board.

Any part or parts replaced under this warranty shall become the property BUELL.

In the state of California only, emission-related warranted parts are specifically defined by the state's Emission Warranty Parts List. These warranted parts are: carburetor and internal parts or fuel injection system; catalyst; oxygen sensors; intake manifold; spark advance mechanism; crankcase breather; air cutoff valves; fuel tank; fuel pump; fuel tank cap for evaporative emission controlled vehicles; oil filler cap; pressure control valve; fuel/vapor separator; canister; igniters; breaker governors; ignition coils; ignition wires; ignition points; condensers, and spark plugs if failure occurs prior to the first scheduled replacement; and hoses, clamps fittings and tubing used directly in these parts. Since emission related parts may vary from model to model, certain models may not contain all of these parts and certain models may contain functionally equivalent parts.

.In the State of California only, Emission Control System emergency repairs, as provided for in the California Administrative Code, may be performed by other than an authorized BUELL dealer or service center. An emergency situation occurs when an authorized BUELL dealer or service center is not reasonably available, a part is not available within 30 days or a repair is not complete within 30 days. Any replacement part can be used in an emergency repair. BUELL will reimburse the owner for the expenses, including diagnosis, not to exceed BUELL's suggested retail price for all warranted parts replaced and labor charges based on BUELL's

recommended time allowance for the warranty repair and the geographically appropriate hourly labor rate. The owner may be required to keep receipts and failed parts in order to receive compensation

## II. LIMITATIONS

This Emission Control System warranty shall not cover any of the following:

A. Repair or replacement required as a result of

- (1) accident,
- (2) misuse,
- (3) repairs improperly performed or replacements improperly installed,
- (4) use of replacement parts or accessories not conforming to BUELL's specifications which adversely affect performance and/or
- (5) use in competitive racing or related events.

B. Inspections, replacement of parts and other services and adjustments required for required maintenance.

C. Any motorcycle on which the odometer mileage has been changed so that actual mileage cannot be readily determined.

## III. LIMITED LIABILITY

A.
